This service is the first time exist in my community of the total population above seven thousand and serve as a social business. There are 17 school in this town ranging from kindergarten to technical high school and access to computers is highly demanding. Students learning computer skills contribute US\$0.25c per hour. I am currently looking for funding to build a permanent center and to expand this service for youth particularly for the girls, the young mother and the dropped out school leavers. My question: Is there any exception for me to apply for this funding?	Individuals are not eligible to receive funding.
